The Edward and Elizabeth Conner Foundation Privacy Policy and Consent

This privacy policy will explain how The Edward and Elizabeth Conner Foundation ("the Foundation") uses the personal data we collect from you and store on our website.

What data do we collect?

The Foundation collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Scholarship information (type of scholarship, year of graduation, etc.)

What data do we NOT collect?

The Foundation will NOT collect the following data:

- Social Security Number (SSN)
- Citizenship/Immigration Status

How do we collect your data?

You directly provide The Foundation with most of the data we collect. We collect data and process data when you:

- Apply for a scholarship (please note, we only save data from recipients, not all applicants)
- Edit your personal information on our website

How will we use your data?

The Foundation collects your data so that we can:

- Communicate with you using your current contact information
- Send your scholarship payments to you
- · Receive required documentation such as your class schedule and transcripts
- Post your name only on our website on our scholarship recipients page (no other data is posted and we can remove your name upon request)

We do not share your data with any 3rd parties.

How do we store your data?

The Foundation will keep your data on our website database until you graduate, at which time we will delete it. We also store data on our Google Drive which will be deleted 5 years after you graduate other than your name and year you were awarded the scholarship.

Your name and year you were awarded the scholarship will stay listed on our public "Scholarship Recipients" website page permanently, unless you request it to be taken off.

Marketing

The Foundation will not use your data for marketing purposes or share your data with any 3rd parties for marketing purposes.

What are your data protection rights?

The Foundation would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access - You have the right to request The Foundation for copies of your personal data. We may charge you a small fee for this service.

The right to rectification - You have the right to request that The Foundation correct any information you believe is inaccurate. You also have the right to request The Foundation to complete information you believe is incomplete.

The right to erasure - You have the right to request that The Foundation erase your personal data, if you are no longer an active recipient, except data that must be retained for The Foundation's tax purposes.

The right to data portability - You have the right to request that The Foundation transfer the data that we have collected directly to you, once are no longer an active recipient, except data that must be retained for The Foundation's tax purposes.
